

## Terms and Conditions of the [www.yamo.pl](http://www.yamo.pl) Sales System

### § 1. General Conditions

1. The following regulations specify the rules for the use of the Sales System [www.yamo.pl](http://www.yamo.pl)
2. [www.yamo.pl](http://www.yamo.pl) - hereinafter referred to as the SYSTEM - is a system that should allow for the registered trading partners shopping at Yamo sp. z o.o. under restructuring - hereinafter referred to as the SUPPLIER - via the Internet.
3. Activating the SYSTEM account, Partner declares that he is aware of these regulations and accepts all conditions without reservation.
4. Complaints arising from ignorance of this document will be considered negative.

### § 2. Access to the SYSTEM

1. Partner who properly filled out the registration form on page [www.yamo.pl](http://www.yamo.pl), and sent the signed regulations, after the positive verification by the supplier receives an active account to log on using the generated by the SYSTEM user name and password on the [www.yamo.pl](http://www.yamo.pl), setting up accounts for its employee, to see prices and place orders.
2. You agree to maintain and use the e-mail address given on the registration form. About any change of address or e-mail, Partner shall immediately inform the supplier.
3. SUPPLIER reserves the right not to grant access to SYSTEM without any reason.
4. SUPPLIER shall not be liable for the consequences by granting access to the Partner login and password to third parties or to an unauthorized person.

### § 3. Purchases

1. Purchasing in SYSTEM is possible only after entering login and password.
2. Orders placed by SYSTEM are treated as made in writing and does not require telephone confirmation.
3. Designated account manager serving the SUPPLIER's order entered with proper username and password is not obliged to check whether the person who places order is authorized to do so.
4. SUPPLIER may put the ordering procedure on hold until receiving telephone confirmation from the Partner.
5. In order to complete the order with the Partner's declared shipment of ordered goods, SUPPLIER uses the services of forwarding companies. Receiving the shipment from the shipping company must be confirmed in writing upon receipt by a person authorized by the Partner.
6. The cost of delivery should comply with the price list available at <http://www.yamo.pl>
7. Placing an order in SYSTEM Partner also accepts the RMA conditions listed on <http://www.yamo.pl> page.

### § 4. Miscellaneous

1. In case of breach of the conditions SUPPLIER has the right to immediately block allocated Partner login and password.
2. Blocking access to the SYSTEM does not relieve the Partner of a settlement of pending Invoices and other obligations in favor of SUPPLIER.
3. SUPPLIER has the right to suspend access to SYSTEM to any Partner who does not purchased from a supplier in period of 30 days.
4. SUPPLIER reserves the right to change these regulations. Partner will be notified about changes immediately through the SYSTEM message on the web service. In case of refusal to accept the new conditions by the Partner, the agreement expires, provided that orders made before the amendment of the Conditions are binding.

On the basis of the Minister of Finance Act of 20 December 2012 the transmission of invoices in electronic form, the rules of storage and making it available to the tax authority or the authority of the tax inspection (Official Journal of 29 December 2012, pos. 1528) all invoices for goods and services issued by Yamo sp. z o.o. under restructuring are delivered via e-mail electronically.
